**One primary source** – a current rental / lease agreement, or rates notice, or unconditional contract of sale  
*Please note that this may be checked and officially validated by the school*

and

**One secondary source** – a utility bill (e.g. electricity, gas) showing this same address and parent's / legal guardian's name

*Applicants should note that a false statement / assertion about the student's principal place of residence may amount to an offence and may be reported to police. The school Principal may repeal a decision to enrol a student in such circumstances.*

## Out of Catchment Enrolments

The student's principal place of residence is outside the catchment area.

Out of catchment students will be considered for enrolment if there is capacity after enrolment of local catchment students.

Expressions of interest from students whose principal place of residence is outside the catchment area will be placed on a waiting list and will be assessed in order of receipt.
